The above offence carries a maximum fine of $£ 1000$, and a 3-6 point endorsement on your driving licence.
However, under sections 75-77 Road Traffic Offenders Act 1988, as amended, this matter may be dealt with by way of the Fixed Penalty Procedure, i.e. a Fixed penalty of $£ 60$ and a 3 point endorsement on your Driving Licence.

5. If you are a hire company, and the vehicle was on hire at the time of the alleged offence, complete Page 4 Part 4.
6. If you have never owned the vehicle, were not the driver and do not have any information regarding the vehicle, complete Page 4 Part 5.
7. If you were the driver of the vehicle at the time of the alleged offence and wish the matter to be dealt with by way of a court hearing, complete Page 4 Part 6 .

## PLEASE NOTE

If your Driving Licence is already endorsed with more than eight current penalty points OR was not issued by DVLA Swansea, you are unable to accept the offer of a Fixed Penalty. You must, therefore, complete \& sign the Drivers Statement overleaf and forward it to the Central Ticket Office together with a photocopy of your Driving Licence. You will then be advised regarding further proceedings.
